### PRESIDENT'S NOTE — NOVEMBER 2023

I also have to extend tremendous appreciation to my fellow officers who really did the hard work. Together we are focused on continuing to make your SFVMA a valuable resource for networking, engaging CE, as well as a conduit to veterinary projects in the community. *Remember that this is your VMA.* We welcome feedback on how we can make it the best it can be.

If you are like me, the year seems to have flown by and it feels strange gearing up for holidays already. I know Halloween has only just past, but the holiday spirit will be in the air in the blink of an eye. Also, I won't have another chance to say Happy Thanksgiving or Seasons Greetings to everyone. So there it was, and I'll throw in a Happy New Year, too.

That said, there is a lot to cover in this letter, so I'll keep it short and sweet. If you are scrolling with one hand and power eating a lunch with the other during your "working lunch break" like so many of our members, you are not alone, and I will avoid wasting your time. First, I want to acknowledge the changing veterinary landscape in the post-COVID lockdown era. I am impressed by the way that our local practices have adapted to the economic, demographic, and industry changes we have been faced with. Congratulations to everyone that has faced adversity in the Bay Area and stayed around to keep practicing here. We are adjusting to new colleagues joining our community and the loss of others to re-location, retirement, and passing on. While it is sometimes difficult to face change, we seem to be on course to continue improving the quality of care for our clients and patients in the Bay Area. I am confident that we will adapt to future challenges, like adjusting to the use of telemedicine in the profession.

Also, Veterinary Vision has a new ophthalmologist. Dr Li Puma will be leading a discussion on treating eye issues at our next meeting. She is joining a new practice and hitting the ground running by presenting to all the local veterinarians that are about to send her referrals. That takes some bravery – let's all make her feel welcome.

If you have read this far and you are coming to the November meeting, you can stop here and go back to work. The following issues will be covered at the next meeting and are important enough that I need to note them for members that might be unable to attend.

Firstly, we may discontinue our help in staffing the Animal Care and Control low-cost vaccine clinics for a few reasons. It has been increasingly difficult to find volunteers. We also have had some feedback that the experience has been more challenging and less fulfilling for our doctors.

Our volunteer officers are very short on time organizing other SFVMA affairs. In the face of losing our current Vice President with no immediate candidate to fill her position, we may need to stop assisting in staffing the low-cost ACC clinics. There will be a formal vote on this at the next meeting. If you want to weigh in and will not be able to attend, please email me.

That leads right into our next urgent matter. The Vice President position needs to be filled as soon as possible. If you are a long-term San Francisco DVM and have never served as an officer, I urge you to step up and serve the Bay Area Veterinary community. If you are newer to the city, then this is your opportunity to impress your associates with your dedication to the community.

If that does not convince you to email me and announce your candidacy, keep in mind you will get a total of eight free meals for the year and your membership fee will be waived. I hope to hear from anyone who may be interested before the November meeting, we can vote then.

The SFVMA policy is to never distribute our member's contact information to any other individuals or organizations. We will only email you regarding Association business or about veterinary affairs or non-profit events we think you may want to be aware of. However, we have had sponsors that want to be able to connect with our members. It could be beneficial if sponsors had the ability to follow up with promotional deals, answer additional questions, and provide lecture slides. I would not want that in my personal email, and I realize many of our members communicate with us via their personal email. At the next meeting I will have a clipboard passed around. ## SFAfA Grant Examples

### General Guidelines

*(GIA and Tauber Funds are available for any case, please use all of your funds)*

- 1 The pet must have an urgent need for medical care.
- 2 The case has a good prognosis.
- 3 If it's a long term problem, the clinic must be able to provide ongoing care.
- 4 Your client must have exhausted all other financial options.
- 5 Your hospital will provide a matching or greater discount/donation of in-kind services
- 6 Your client must reside in, or have significant connection to, the San Francisco Bay Area.

### Condition Examples

*(List is not all inclusive. Please reach out to us with any questions!)*

- Infectious diseases (Parvo virus, feline panleukopenia, influenza, anaplasmosis...)
- Hepatitis / Liver Disease
- Gastro-enteritis, hemorrhagic gastro-enteritis, inflammatory bowel disease

Just a reminder to those using our grants this year. As a way to help you help more pets in need, the GIA match has been lowered to 50% this year. This very successful program has been in existence for over ten years and we have sent out more than 15,000 cards on your behalf.

# LETTER FROM ANIMAL CARE & CONTROL

Dear Practice Owners/Managers,

Thank you for being part of the San Francisco animal community and caring for the many pets in our City.

We understand that this is a demanding time for veterinary practices. We are writing to remind you that the San Francisco Health Code requires that all rabies vaccination information for dogs must be reported to the Department of Animal Care and Control within 30 days of administration.

To maintain compliance please submit copies of your rabies information to **acc.rabies@sfgov.org** by the 5th of every month. Attached is a sample spreadsheet containing the required information. If your system is unable to produce a report, please provide a pdf version of your rabies certificates. The rabies certificates must contain the following fields:

Owner — Last Name	Animal — Name

Dog licensing is required by law as part of our rabies control program. Licensing also remains an essential tool in returning lost pets to their guardians. It also helps SFACC determine where to focus our outreach and emergency planning efforts.

The city is currently using licenses made by Pet Hub ([www.pethub.com](http://www.pethub.com)) that include a QR code where the basic plan enables anyone who finds a dog to scan the code and obtain owner-supplied information about the pet and its family, speeding reunification. Last fiscal year, SFACC reunited 54% of stray dogs with their owners through our lost and found programs.

Veterinarians who are licensed in another State may be qualified but must acquire a valid license from the State of California to practice veterinary medicine at time of appointment. Note: A prospective veterinarian who is licensed in another state may be hired by the City of Fresno while in the process of obtaining their State of California license. The incumbent must acquire their California license within six (6) months of appointment and cannot practice or serve as the City's Veterinarian until such time valid license to practice veterinary medicine issued by the State of California Veterinary Medical Board is granted.

Possession and continued maintenance of a valid California Driver's License is required within sixty (60) days of appointment.

Must obtain valid Drug Enforcement Agency (DEA) license within ninety (90) days of hire and maintain a valid license while employed. May be required to hold the Veterinary Premises License issued by the State of California Veterinary Medical Board.
